- Have a Federal Tax ID Number *photocopy proof required***
- State Resale License *photocopy required* for any state that you have a physical presence**
- Out of State Resale License will be required for drop-ships to certain states (CA) or states that you have economic nexus**
- Business License *photocopy required***
- Send current pictures of building with Store Sign *Required***
